Meeting with SA Treasurer – Ray Hickman, Dianne Baron and I, met with Treasurer Stephen Mullighan on 9 August 2022. We offered PS Superannuants as a consultative body on relevant superannuation matters and spoke to key items detailed in our pre-election submission, and a range of other matters. Our request for SA to adopt the maintenance of spousal payments for up to 7 pays following the death of a member, in line with Commonwealth arrangements – was not supported by the Treasurer, who considered our current superannuation arrangements generous by community standards. We will continue to press our case on these matters.

Membership – thanks to Secretary, Dianne Baron our updated membership brochure will be distributed to Super SA members in the coming weeks. While it is relatively expensive the brochure is, in reality, our main source of attracting new members. We do get a few new recruits from members spreading the word and introducing friends and encouraging them to join.

Brochures will be available at meetings, or you can refer potential members to our website where they can find out lots more about us and the benefits of membership and join online.

Newsletter -thanks to everyone who responded regarding the layout of our newsletter, and preference for electronic or hard copy. 

Scams and Identity Theft



Scams and identity theft

Scammers try to steal your money or personal information – they are modern day fraudsters. Scammers contact thousands of email addresses and phone numbers every day, and when scammers first contact you, they won't have any information about you, scammers try to collect personal information.

Beware of Centrelink impersonation scam calls

Members have recently experienced calls claiming to be from the Services Australia Centrelink legal team advising them that they have a debt due to overpayment.

These callers sometimes claim:

- if you don't pay it straight away, you'll be arrested
- you can pay through a bank transfer, gift cards or cryptocurrency.

This call is a scam.

Centrelink will write to you via post or your myGov inbox if you do owe money, so if you do receive this type of call hang up.

Pensioners to benefit from Jobs Summit

Relaxed rules so that seniors can work extra hours without losing their pension entitlements is one of 36 outcomes agreed on at the government's jobs and skills summit.

Under these changes, pensioners will receive a one-off income credit so working seniors can earn an extra \$4000 over this financial year without losing their pension, but this new measure is only temporary.

This strategy is designed to assist in addressing Australia's current skills shortages and has been determined as a "time-limited measure".

Pre-Budget Submission for the October 2022 Budget

In our introductory letter we explained once again the tax differences between our superannuation pensions and those paid under the Superannuation Guarantee. The common assertion of our pensions being generous by community standards does not stand up to close examination when all three pillars of the retirement income system are taken into account, along with the taxation differences. We acknowledged that our pensions are good but not better than the Superannuation Guarantee.

In our submission we set out seven suggestions for changes to retirement income arrangements:

- 1. The pre-1 July 1988 reaction of untaxed source, defined benefit pensions to be tax-free after age 60
- 2. Age pension to be non-taxable income for all Australians
- 3. The 10% cap on defined benefit pension income that is exempt from the age pension income test should not apply when the exempt amount has been calculated using only a person's after-tax contributions for which no tax

deduction was claimed prior to pension commencement

- 4. Complete removal of, or a substantial increase in, the current age restriction (75 Years) at which a person's right to make non-concessional contributions to superannuation is lost
- 5. Immediate implementation of higher income cut-out points for Commonwealth Seniors Health Card eligibility as promised during the 2022 Federal Election
- 6. Age-related valuation of defined benefit pensions for the transfer balance cap
- 7. People in receipt of age pension to be allowed to earn income that is not counted in the age pension income test.

GOOD, BUT NOT BETTER THAN SUPERANNUATION GUARANTEE

On the subject of Compulsory Super, another recent press release from National Seniors and Challenger Ltd about a large survey they undertook on retirement income on the 30th anniversary of compulsory superannuation in Australia, has revealed some interesting results. These include the opinion that 30 years of the compulsory super system had enabled older Australians to enjoy a comfortable retirement, and that it is truly a 'guarantee' for a better later life. The Adelaide CPI change for the period 1 July-31 December 2021 was an increase of 2.21% and this change to Super SA pensions will occur in April 2022.

CSS and PSS pensions increased by 1.5% in January 2022.

Legislation is currently moving through parliament that will see the Income Caps for Seniors Health Card eligibility increase to \$90,000 for Singles and \$144,000 for Couples.
