From the President



Inflation winners and with high losers inflation impacting on the price of everything, the winners big include banks, major airlines, energy companies, and supermarkets proudly reporting huge profits. Other winners are the

CEOs and managers of the big companies, many of whom take home obscene salaries and bonus payments.

The losers in the main are the ordinary folk in our society who struggle to cope with the increased cost of home mortgages, rent (if you can find somewhere suitable), food, electricity, gas, health insurance, fuel for the family car, and other basic necessities.

Those of us who receive a defined benefit superannuation pension are shielded somewhat from the price rises by having our DB pensions increased through the indexation of our pensions via the CPI reviews every six months – 3.6% in December 2022 and 3.3% in June 2023. Without those increases we would obviously be far worse off financially. On the other hand, if our DB pensions were indexed in the same way as Age Pensions are, we would be better off.

Our Strategic Plan – continues to be rolled out as we strive to ensure the future and direction of PS Superannuants. Phone calls to a random selection of members has commenced with the

purpose of finding out expectations of members, and we look to recruit members to take on positions on the management committee in Adelaide and on the sub-committee in Melbourne. You might get a call from one of the team asking for your views. Even if you don't get a call, please think about taking on a position. We have already had success from our advertising more widely for volunteers when we welcomed Jim Rhodes to our committee in Adelaide. Jim has a background in accounting and management at the Commonwealth and SA State level.

The Superannuant — our regular newsletter is distributed in hard copy and via email. You can reduce postage and print costs, while reducing our carbon footprint, by opting to receive The Superannuant electronically. Just let us know if you want to try a change.

General Meetings – taking the lead from our subcommittee people in Melbourne, thanks to Peter Frick our Communications Manager, our general meetings in Adelaide are now being video recorded and include guest speaker presentations. You can have a look at the vision from our Adelaide and Melbourne meetings on our website if you would like to catch up.

Our Finances – will be improved with a proposed increase in membership fees for 2024, however as Treasurer **Mike Evans** said in the previous newsletter, we would appreciate donations from members to top up our operating account.

as a geographer, working in regional South Australia in wetland restoration and park management, leadership within Aboriginal community engagement and oversight of key environmental policy programmes.





Vale Comrade Vic, 11/6/1931-1/7/2023.

On 1 July 2023, Association Victor stalwart Milton Potticary left on that from journey which no traveler returns. Vic was born in 1932 during the great depression and was one of five children when, in 1937, his father, a railway worker at Pirie, Pt died suddenly. Vic's



mother moved the family to Goodwood Park from where he attended Goodwood Primary School then Adelaide High.

Vic left school for employment as an apprentice compositor with the *Co-operative Printing and Publishing Society*, an organization which printed the communist newspaper *'Tribune'*. He became, and remained, a staunch supporter of socialist causes both at work and in ordinary life. While Speaker's Corner was being held in Botanic Park on Sundays Vic thoroughly enjoyed attending and, occasionally, doing a bit more than just listening. However, his political preferences never influenced the service he rendered to the Association.

Vic married Audrey in 1953 and their son Malcolm was born in 1955. Audrey and Malcolm both pre-deceased Vic. Audrey was, herself, an activist who played a prominent part in the 'Save our sons' campaign against conscription during the Vietnam war. Vic was not backwards in coming forward to let people know that ASIO, at one time, had files on each of them. This was something seen by both as a badge of honor.

In 1975, Vic commenced work at the South Australian Government printing office. He joined the *Public Service Association (PSA)*, and the *Printing and Kindred Industries Union (PKIU)* along with the *Australian Labor Party*. The PKIU later became part of the current *Australian Manufacturing Workers Union (AMWU)* which, in 1999, bestowed on Vic an *Award of Merit* for 52 years' service to the printing industry. In 2007, SA Unions published the book 'Movers and

Shakers' which was a collection of 'stories of activists who have made a difference in South Australia'. Vic was one of those activists.

2007 was also the year in which this Association conferred Honorary Life Membership on Vic for his service as Vice-President, Secretary and for his contribution to production of *The Superannuant*. Anyone who relied on Vic was never disappointed or let down. He was always there to assist in getting the job done.

All those who knew, and admired, Vic take comfort from the thought that he is now reunited with Audrey and Malcolm.

Vic was secretary when I became treasurer in 2005, and he was a great help to me as I learned the job; he had a thorough knowledge of the Association's business, and of course he was very easy to work with. Treasurer's Report



The Association's finances were discussed at length at the Strategic Planning Meeting, and it was agreed that some serious changes are essential to assure our financial future. At present our expenses are around \$20,000 p.a., (newsletter \$9,000; insurance \$4,000; hall hire \$2,600; honoraria

\$1,200; audit \$1,000; P.O.Boxes \$650; guest speakers \$400; ACPSRO, COTA \$200) whilst our income comprises annual membership dues and a small amount from our investments; we have ~400 financial annual members, at \$30 p.a. each this gives us \$12,000; our investment income has averaged \$2500 over the last 10 years. Clearly there is a large gap between our expenditure and income.

Possible measures we discussed to address this situation were:

We could produce two newsletters per year instead of three, this would save about \$3,000 p.a. However, the newsletter is the heart of the Association, and we already have difficulty fitting all the material we want to put out to members in three newsletters. Furthermore, this measure would only lessen, not solve, our financial problem.

We could make the newsletter online only, however we have newsletter email addresses for only 666 of our members, so we must print at least several hundred newsletters, so we would still have the costs of setting up the newsletter, halving the numbers printed would not halve the production cost. Also, many of our members, even those with email addresses, like to receive a printed copy.

We could charge for a printed copy of the newsletter; however, this would be unwieldy to administer, and in my view quite impractical.

As I noted above, the newsletter is the heart of the Association. It is the only contact we have with 90% of our members, and the fact that you keep supporting us shows you like the present arrangements. Therefore, I strongly support keeping the present arrangements for the newsletter.

The problem lies in the fact that a thousand of our members are life members and we receive no income from them. In view of our present expenditures, we probably set our life fees too low, however the association is now very different from, and much more costly to run, than it was when these fees were set.

We believe it would be very unfair to annual members to try to reform our finances solely through increased annual-membership fees.

Therefore, I have proposed, and the committee has endorsed, two measures: first we will no longer offer new life memberships, and secondly, we will introduce an annual fee of \$15 for existing life members. I have spoken twice about this at general meetings and members have been very supportive, and no one has spoken out against it. Of course, only 50 or so members attend general meetings, and the wider membership may not be so supportive.

I do encourage members to contact me via the APSS website and give me feedback on these proposed changes. Assuming there is not a large number of members opposed to the changes, I will put a motion to the AGM in February and if this is passed the new fees will apply from that time. If the response from members is what I hope it will be, our income should at last exceed our expenditure, our financial future will be secure.

Strategic Planning Day Report

PS Superannuants is an Association owned by members and run by volunteers.

PS Superannuants is the only Association that represents retired public sector defined benefit superannuation recipients.

Please be advised that the Association is now facing a number of extreme challenges, these include reduced revenue at a time where running costs have escalated, low committee participation and declining membership.

In May 2023 the Executive Committee along with a number of members undertook Strategic Planning processes to determine the future of the Association. This process included undertaking a Strength, Weaknesses, Opportunities and Threats (SWOT) Analysis. The SWOT outcomes have since been prioritised and developed into 3 defined Priority Action Plans to address the immediate risk and threats to the Association.

These Priority Actions are aimed at Recruiting Office Bearers, Restructuring Association

Finances and increasing Stakeholder Engagement.

For the Association to meet Legislative obligations and operational requirements in 2024, a new Committee must be formed, and a new President, Vice President, Secretary, and Committee Members recruited before the end of 2023

Currently the Association relies on the revenue gained through Annual Membership and any interest made on investments. The everincreasing cost of postage and printing for the Superannuant, venue hire for meetings, technology investment, insurance and overall running expenses place the Association in a financial vulnerable situation. Therefore, the Associations finances must be restructured, and members will be consulted about this via a phone survey that is currently underway.

Results of the member consultation will be presented to the Committee in November along with all the outcomes of the Actions Plans. The Committee will then need to determine if it can meet its legislative obligations in relation to committee requirements for 2024. If Committee Nominations for 2024 can be confirmed, AGM Notifications will be activated as per standard procedures.

If the Association is not able to confirm a 2024 Committee at that time, as per Constitutional requirements members have until 5 pm 21 January 2024 to nominate for the Committee. Then if no further Committee Nominations are received the Secretary will seek direction from the President or the Committee and as a result - may call a "Special General Meeting".

Members are the Associations Key Stakeholders - as PS Superannuants is an Association owned by members and run by volunteers.

Participation on the Committee only takes a few hours a month and provides individuals a collegiate supportive environment — with no expectation that members are subject experts in superannuation but are interested in supporting the Association to continue operations.

Therefore, please consider nominating and getting involved.
